**REF: COMMITTEE STAGE AMENDMENTS TO THE KILIFI COUNTY STATUTE LAW (MISCELLANEOUS AMENDMENTS) BILL, 2020.**

**NOTICE** is given that Hon. Scholastica Adit Oduol, Chairperson to the Sectoral Committee on Justice and Legal Affairs intends to move the following amendments to the Kilifi County Statute Law (Miscellaneous Amendments) Bill, 2020 at the Committee of the Whole House Stage;–

**1. Kilifi County Transport (Regulation and Control) Act, 2015**

- a. That, Section 18 of the bill be amended by inserting the phrase “and motor-cycle” immediately after the word “vehicle”.
- b. That, Section 144 of the bill be amended by inserting the phrase (first time offence) immediately after “1500” under the penalty column and further amend by inserting 6000 (second or subsequent offence).

**2. Kilifi County Valuation for Rating Act 2016.**

- a. That the bill be amended by deleting the nature of offence and the penalty of 3000 and substituting thereafter with the following ; (***Offence to willful hinder or obstruct the valuer in exercise or attempted exercise of the powers as provided in the Act, offence to neglect to furnish particulars within 14 days by rateable owner or occupier after being called upon to do so, offence to furnish false statement of a value or any other particulars in the exercise***) and further amend by providing for the new penalties as; **3000** (***Offence to willful hinder or obstruct the valuer in exercise or attempted exercise of the powers as provided in the Act***), **3000**(***offence to neglect to furnish particulars within 14 days by rateable owner or occupier after being called upon to do so***) and **4500** (***offence to furnish false statement of a value or any other particulars in the exercise***) at the penalty (Ksh.) column respectively.

**3. Kilifi County Revenue Maternal New Born and Child Health Act, 2016**

- a. That the Bill be amended by deleting the word “***Revenue***” appearing immediately after the word “County” in the title of the Act.
- b. That the bill be amended by deleting Section 7 and its provisions.

**4. Kilifi County Agriculture Development Fund Act 2016**

- a. That Section 28 of the bill be amended by deleting the phrase "**destroy or misappropriates security given in relation to the guaranteed loan**" immediately after the word "**for**".

**5. Kilifi County Ward Scholarship Fund Act, 2018**

- a. That, Section 34 of the bill be amended by deleting the phrase "**misappropriation of funds or assets from the fund**" appearing immediately after the word "**committee**".
