NON-OPERATIONAL COUNTY PLOUGHING TRACTORS

Hon. Mramba: I am holding brief on behalf of hon. Kenga to present a Statement to the County Executive Member In charge of Agriculture, Livestock and Fisheries:-

Whether the County Executive Committee Member is aware that most of the ploughing farm tractors of the County Government are not operational?

If the County Executive Committee Member is aware of the above, considering that the long rains are expected any time from now and that farmers want to prepare their farms for the planting season, what action is she taking to address this problem? Whether the County Executive Committee Member is aware that the 2017 Tailoring and Dress making class of Adu Youth Polytechnic was not registered for the final examination yet they paid examination registration fees within the stipulated timelines?

The Temporary Speaker (Hon. (Ms.) Maneno): Yes hon. Baya.

Hon. Baya: I stand to be guided; on the 6th of December, 2017, I raised a Statement concerning garbage collection in Watamu but until now nothing has been done. The people of Watamu are in danger. The garbage in that town has not been collected for the last three months; I fear for a cholera outbreak.

The Temporary Speaker (Hon. (Ms.) Maneno): Thank you. Hon. Members. I therefore direct the Chairperson for Agriculture, Livestock and Fisheries to Table the response within 14 days. Is the Chairperson within this House? I also direct the second Statement from hon. Kenga to the Chairperson for Pre-Primary Education and Vocational Training to Table a response within 14 days in this House. Is the Chairperson present? What of the vice Chairperson?

To respond on hon. Baya concerns, the Statement was laid before the House on Wednesday, 6th December, 2017. From practice, the Chairperson of Committee on Water, Environment, Natural Resources and Waste Management should have gotten the response in 14 days. If there are challenges, the Chairperson should notify the House so that the House can follow up on the matter. I now further direct the Chairperson to report back to the House on Wednesday, 21st February, 2018. Thank you.
