ADOPTION OF THE REPORT ON WATER SHORTAGE (NORTH COAST FORUM)

Hon. Hamza: Thank you Mr. Speaker, Sir, for giving me this opportunity. I would like to inform this House that I am holding brief for the Chairperson of Water and Sanitation hon. Hassan who is not with us today.

We had an opportunity to go round and had a sitting on the 29th of February, 2016 to deliberate on matters pertaining to water crisis. By then, there were lots of issues facing the water sector because there was an acute water shortage.

The water sector was facing a great challenge and it could not maintain the constant water flow supply in the county. This led to the Committee holding a special sitting to deliberate on the matter and various stakeholders were invited to participate. There are a lot of findings that we had and definitely according to the findings it will force this House to make some determinations.

Having had consultations with the various legal experts of this Assembly, we found it fit that the Committee needs time to do a Motion so that some of these issues can be addressed. This means that the House will be given an opportunity to deliberate on all the matters through a Motion. Therefore if that one is in agreement, I would like to sit and wait for that opportunity when the Committee will be accorded time by this House to sit and do a Motion and incorporate all the matters involved so that this House can be at liberty to rule out on the said issues. Thank you.

The Speaker (Hon. Kahindi): Thank you hon. Hamza. Indeed I have personally looked at the Report and it raises substantive issues which ought to be deliberated on. As requested by the hon. Member, I direct that the Committee moves ahead to do a substantive Motion that will be able to address the substantive issues that have been raised especially on the recommendations made by the Committee.
