THE KILIFI COUNTY ROADS TRANSPORT AND PUBLIC WORKS (REGULATION AND CONTROL) BILL, 2015

**Hon. Mupe:** Thank you Mr. Speaker, Sir, The Kilifi County Transport (Regulation and Control) Bill, 2015 was read for the first time on 13<sup>th</sup> July 2015 after which the presiding Speaker committed it to the Sectoral Committee on Transport and Public Works and directed that the Committee scrutinizes the Bill and submits a report in twenty one calendar day.

Pursuant to Article 196 Clause (b) Standing Order 120 Clause 3, the Committee invited interested Members of the public through advertisement in the National and Local dailies on Tuesday 28<sup>th</sup> and Wednesday 29<sup>th</sup> July 2015 to submit their memorandum or any representations they may have on Kilifi County Transport and Regulations and Control Bill, 2015 to the Clerk of the County Assembly of Kilifi by Thursday 6<sup>th</sup> August 2015.

The Committee further had consultative meeting with the County Executive Member for Transport and public Works, the Chief Officer and his legal team on 23<sup>rd</sup>, 24<sup>th</sup> July 2015 and from 9<sup>th</sup> to 11<sup>th</sup> September 2015. Mr. Speaker, Sir. As I speak, no memorandum from members of the public was received on this Bill.

The purpose of this Bill is to provide the County Government of Kilifi with powers, functions and responsibility to regulate and control the means of transport within the County of Kilifi and the Committee proposed various significant amendments for the betterment of the residents of Kilifi. Mr. Speaker, Sir, once this report is adopted in this honourable County Assembly, the Kilifi County Transport (Regulation and Control) Bill, 2015, shall therefore be structured as follows;

- Part I of the Bill set out the preliminary matters including the commencement date and definition of various terms used in the Bills.
- Part II of the Bill establishes the department of Transport how it will be set up, its offices and staff, functions, powers and among other ancillary matters
- Part III of the Bill outlines broad regulation of the sector in terms of traffic, public read transport and street lighting.
- Part IV of the Bill provides for orderly parking of vehicles.
- Part V of the Bill is on how ferries and harbors shall be licensed and operated.
- Part VI of the Bill provides for safety and adequacy of service provision coupled with charging and payments of just and reasonable charges on those receiving the services
- Part VII of the Bill provides for transport by way of light railway and its general control.
- Part VIII of the Bill provides for general provisions including penalties, regulations and the repeal of by-laws.

Mr. Speaker, Sir, I wish to confirm that the purpose of this Bill takes care of the interest of the residents of Kilifi County by ensuring a balanced transport facility and planning by providing for adequate, safe and efficient transport facilities and services to the County.
