PERSONAL STATEMENT

EXTRAJUDICIAL KILLING IN KAYAFUNGO WARD

Hon.Mwayaa: Asante Mheshimiwa Spika. Kulingana na Kanuni ya 80 hiyo ni katika *Standing Orders* zetu, kwangu kuna migodi ya mawe yale yanaitwa maghalana hiyo ni Kayafungo sehemu za Tsangatsini. Tarehe 26 saa tisa usiku kuna lori lilienda kubeba mawe ambayo ni magalana kwa sababu barabara ni mbaya gari lile likakwama kwa matope. Lilipokwama kuna vijana walijitokeza kusaidia hilo gari litoke na wengine walikuwa ni watoto wa shule. Waliposhika miko na majembe kuchimba lile gari kusaidia litoke, mwenye gari aliona labda hilo gari linachelewa huko timboni akaenda kuripoti kwamba gari lake limeibwa na majambazi. Polisi wa Mariakani wakachukua hatua kwenda sehemu hiyo kutafuta hilo gari.

Walipofika hapo walizingira gari na wakaamuru kwamba vijana wale waliokuwa wanasaidia ile gari walale chini. Vijana wawili hawakulala kwa sababu walifikiri labda ni *Al-Shabab* ama ni watu ambao hawaeleweki wakaamua kukimbia. Kijana mmoja akapigwa risasi na jana tulifanya *post mortem* risasi iliingia na mkono kwa kulia ikapasua moyo na ikatoka na hapa chini ya mbavu za mkono wa kushoto. Polisi walipojua kwamba wameua, wakitisha gari lao na kubeba maiti na kwenda kuiweka *general mortuary, Mombasa*. Baada ya hapo uvumi ukatoka kwamba kuna jambazi aliyeuawa baada ya kuona yule kijana miaka yake bado ni kidogo na yuko darasa la saba wakageuza stori wakasema tumeokota mwili wa mtu asiyetambulika ambao ulikuwa umejeruhiwa sana.

Ilibidi juzi tuandamane na pia mashirika yasio ya kiserikali yakatusaidia kama HAKI Africa, IPOA na Mbunge wa sehemu ya Kaloleni. Tulipomaliza kufanya *post mortem*, ilidhihirika wazi kwamba ni risasi iliyoua yule kijana. Kwa sababu risasi mbili zilisikika huyo kijana wa pili alikuwa anaruka ukingo wa shamba akaanguka, risasi ikapita kwenye sikio na yeye akapona. Yeye na wengine wanatoa ushahidi kwamba mwenzao alipigwa risasi. Baada ya hicho kitendo, wakakalishwa chini mpaka asubuhi na OCPD wa Mariakani akaja kuwafungua. Walikuwa wamempiga pingu dereva. Gari likaendelea kuchimbwa tena hadi saa tisa mchana ndio likafaulu kutoka.

Nimeona nifahamishe Bunge hili ni kitendo cha kinyama kilichofanyika. Pia, nawaomba wenzangu tujumuike wakati wa mazishi ambayo tunapanga kutoa mwili Ijumaa na kuzika sehemu za lokesheni ya Kayafungo, Tsangatsini. Nimeona niwaelezee Bunge hili maana kitendo hicho ni cha kinyama kama *trained officers* si kudhani wanaweza kuchukua hizo hatua walizochukua.

The Temporary Speaker (Hon. Thaura): That is so unfortunate hon. Mwayaa and we as the House have received your Personal Statement.
