ADOPTION OF THE COMMITTEE REPORT ON THE REPORTS OF THE AUDITOR- GENERAL ON THE FINANCIAL STATEMENTS OF MALINDI WATER AND SEWERAGES COMPANY (MAWASCO) LIMITED FOR THE FINANCIAL YEAR ENDING 30TH JUNE 2014, 2015, 2016

Hon. Hassan: Point of Order.

The Temporary Speaker (Hon. Mumba): Yes, Member for Matsangoni.

Hon. Hassan: Thank you Mr. Speaker, Sir. I am standing Pursuant to Standing Order 49. That, I wish to withdraw the Notice of this Motion;

THAT, this House adopts the Report of the select committee on County Public Investments and Accounts on the consideration of the Reports of the Auditor-General on the Financial statements of Malindi Water and Sewerage Company (MAWASCO) Limited for the financial year ending 30th June 2014, 2015, 2016 laid on the Table of this House on Monday 6th May, 2019.

Hon. Ziro: Point of Order, Mr. Speaker.

Hon. Hassan: Reasons, we need to have enough time so that we can go through the Report and debate on the findings and recommendations from an informed point of view.

Hon. Ziro: Point of Order Mr. Speaker.

Hon. (Ms.) Messo: Point of Order Mr. Speaker.

The Temporary Speaker (Hon. Mumba): Hon. Members, the Member stood on a Point of Order and he was just giving his contributions. So, it was upon you to give him enough time to present what he had to present before you interfere; that is why I allowed him to continue. And again Member you need to make your request; it is not a matter of you shouting Point of Order. Press your intervention then I will see it here and allow you to talk.

Hon. Mwarandu: Mr. Speaker, the Motion before us here is a Motion from the select committee on Public Accounts and Investments, which was tabled by the relevant Chairperson. Now, the Member who has adjourned this Motion under Standing Order 49, we do not know which Motion he wants to adjourn and he is not a Member of PIC/PAC.

Hon. Hassan: Asante sana Mheshimiwa Spika kwa kunipa hii nafasi nijieleze. Nimesimama kwa niaba ya Mwenyekiti wa kamati ya PIC/PAC baada ya kuongea na kuniruhusu kufanya hivyo.

Hon. Mwarandu: I do not concur with the hon. Member for what he has given us here because he is not a Member of PIC/PAC and it is not the practice that any Member of this House can stand for the Chairperson of any committee. It is either in the absence of the Chairperson, the vice chairperson or any Member of the committee can stand for. He is standing for a Chairperson while the Member himself is not a Member of the committee. Is that the practice Mr. Speaker?

The Temporary Speaker (Hon. Mumba): Thank you. Hon. Members, I have heard your concerns but I want to make clear before this House. Now that the document was tabled yesterday and it is at that point of tabling the document that the law requires that it is either the Chairperson or any Member of the committee. But, once the document has been tabled, the Chairperson can delegate any Member of this House to execute that role.

That is why hon. Hassan is in order to move that withdrawal. Pursuant to Standing Order 49, a Notice of Motion may be withdrawn by the Member who gave the Notice but Notice of the same Motion may be given again either by the same or any other Member. So, the Member is very much in order and I hereby direct that this Motion be brought before this House after the recess. Thank you, hon. Members.
