

**THE KILIFI COUNTY FINANCE BILL, 2013**

**AN ACT of the County of Kilifi to provide for various taxation, imposition of taxes, charges for services and other revenue raising measures by the county government; and for matters incidental thereto**

**ENACTED** by the Government of the County of Kilifi, as follows—

**PART I—PRELIMINARY**

Short title and commencement.

**1.** This Act may be cited as the Finance Act, 2013 and shall come into operation on such a date as the County Executive Committee Member for Finance may appoint and different dates may be appointed for different provisions.

**PART II— FEES AND TAXES PAYABLE AND RATES APPLICABLE**

Imposition, revision of the taxes, fees, etc of the County.

**2.** (1) The taxes, fees and charges set out in the Second column of the First Schedule shall apply for the respective services and at the rates set out therein.

(2) The respective taxes, fees and charges, together with the rates applicable shall take effect in not later than three months after the commencement of this Act.

(3) For greater certainty, the taxes, fees and charges applicable at the commencement of this Act shall continue to apply under the existing by-laws of the defunct County Council of Kilifi, Town Council of Kilifi, Town Council of Mariakani, County Council of Malindi and Municipal Council of Malindi until such by-laws are repealed and replaced by county legislation.

**3.** All directions, resolutions, orders and authorizations on financial management,

including the collection and administration of taxes, fees and charges given or issued by the defunct County Council of Kilifi, Town Council of Kilifi, Town Council of Mariakani, County Council of Malindi and Municipal Council of Malindi and subsisting or valid immediately before the cessation of the application of that Act shall be deemed to have been given, issued or made pursuant to this Act, until the expiry, amendment or repeal of those directions, resolutions, orders and authorizations on financial management and shall continue, with the necessary modifications, apply to the payment and the administration of the taxes, fees and other levies under this Act
