THE PUNGUZA MIZIGO (CONSTITUTION OF KENYA) AMENDMENT BILL, 2019

Hon. Kenga: Thank you very much Mr. Speaker. I beg to give Notice of Motion on the consideration of the Punguza Mizigo (Constitution of Kenya) Amendment Bill, 2019 pursuant to Article 257 of the Constitution of Kenya, 2010:-

THAT, aware that Article 157 of the Constitution of Kenya, 2010 provides the process for the amendment of the Constitution of Kenya by popular initiative.

AWARE THAT, Article 257(5) provides that if the Independent Electoral and Boundaries Commission is satisfied that the initiative meets the requirement of that Article, the Commission shall submit the draft Bill to each County Assembly for consideration within three months after the date it was submitted by the Commission.

FURTHER AWARE that, the Chairperson of the Independent Electoral and Boundaries Commission vide a letter dated 18th July, 2019 officially transmitted the Punguza Mizigo (Constitutional Amendment) Bill 2019, promoted by Third way Alliance Kenya to the County Assembly.
