1. Ngabena – Mianzini road.
2. Chauringo – Mango road.
3. Chauringo – Pendeza road.
4. Pangani – Maloma – Mto Mkulu road.
5. Chigangoni – Mbwaka – Pangani road.
6. Mbwaka –Cobra –Kwa Shashara road.
7. Makobeni Kibandani – Kwa Makashero road.
8. Bondora – Kwa Ngundo – Daniel Mwalimu road.

#### DEPLORABLE STATE OF MRAMBA – CHAURINGO ROAD

Two, why has the watchman not being paid his salary for the said period and what plans is the CECM taking to pay the watchman? Thank you Mr. Speaker, Sir.

STAFF SHORTAGE AT KILIFI COUNTY HOSPITAL MORGUE

**Hon. Kiraga:** Thank you so much Mr. Speaker. On behalf of the Chairperson, Health Services Committee, may I read the following Response. This Response is about a Statement sought by hon. Pascal Jacob Thuva on the Kilifi County Hospital morgue:-

The Department of Health Services is aware of the concern of long waiting time for morgue services at night at Kilifi County Hospital. This has been occasioned by staff shortage at the unit. Upon receiving the complaint on the 29<sup>th</sup> of October 2019, the Department shared the same with the Medical Superintendent at Kilifi County Hospital and advised him to address the matter and give a feedback to the County Directors, Chief Officers and CECM for Health Services.

The Medical Superintendent presented this matter to the Hospital Management committee during morning briefs held on 4<sup>th</sup> November 2019 at the Medical Superintendent's office. (Minutes of the meeting enclosed)

He explained to the committee of the community's concerns on long waiting time for services at the mortuary during the night. Currently there is a staff on night duty at the mortuary hence operations are 24 hrs (duty Rota attached). The Department is in the process of expanding mortuary services including the recruitment of mortuary attendants. We shall endeavor to strengthen health service delivery in all areas and appreciate your continued support. Thank you so much Mr. Speaker.

**The Speaker** (Hon. Kahindi): Yes, hon. Pascal.

**Hon. Pascal:** Thank you Mr. Speaker. Let me congratulate the Chair and the Department for taking the appropriate measures to ensure that this problem is sorted. The reason I sought this Statement is because on many occasions there has been a public outcry on how this morgue services have been provided at the main hospital for Kilifi, that is why on like three occasions I had to visit personally because I had lost a student and had to stay there for over five hours. So I brought this Statement and I think the Department has taken the appropriate measures and this is the way to go Mr. Speaker. Thank you very much.

- 1) The County Directorate of Citizen's Participation and Civic Education shall perform such activities to provide civic education for the objectives as follows:
  - a) To enhance knowledge and understanding on the Constitution of Kenya 2010.
  - b) To promote Constitutionalism and up holding to the rule of Law.
  - c) To increase efficiency and effectiveness in implementation of Devolution.
  - d) To support the expansion of citizen participation in public affairs and political processes particularly for the marginalized groups and communities.
  - e) To enhance effectiveness and efficiency in advocacy and lobbying for the implementation of community projects to quality basic service delivery by the duty bearers.
  - f) To promote fulfillment of access to human rights and responsibilities according to County Government Act Section 137.
- 2) The County Directorate shall appoint an officer in charge with Civic Education within the directorate.

- f) Should meet the requirements of Chapter Six of the Constitution of Kenya.
- g) Posses basic knowledge on the Constitution of Kenya.
- h) Should not be an official of any political party.
- i) None state actors.
- j) Certified civic education providers who are none state actors may conduct civic education in the County civic education guidelines.
- k) None state actors shall coordinate with the directorate at all times as they carry out civic education.

**Hon. Mwambire:** Thank you very much Mr. Speaker and thank you hon. Thomas Mumba for correcting me but I had already cited that mistake. So, as it envisaged in the Kenyan Constitution that Citizens should be fully involved in terms of project implementation, I hereby support this Motion that the House passes it.

In the past, we have had a lot of engagements with our people in terms of development matters in different forums without a Bill. I want to thank my Chairperson and the whole Committee; I want to thank you hon. Speaker too for enabling the Committee to go through this Bill making those amendments passed by this House.
