## **REF: COMMITTEE STAGE AMENDMENTS TO THE KILIFI COUNTY AGRICULTURAL TRAINING CENTERS BILL, 2024**

NOTICE is given that Hon. Ronald Kazungu Mbura, Chairperson to the Sectoral Committee on Agriculture, Livestock and Fisheries intends to move the following amendments to the Kilifi County Agriculture, Livestock and Fisheries Bill, 2024 at the Committee of the Whole House Stage -

1. That clause 9(c) be amended by deleting **ten** appearing between “**than**” and “**years**” and replace it thereof with **five** and deleting **five** appearing between “**which**” and “**must**” and replace thereof with **two**.
2. That, Clause 18(a) be amended by deleting **10%** appearing between “**Least**” and “**of**” and replace it thereof with **15%**.
