REF: COMMITTEE STAGE AMENDMENTS TO THE KILIFI COUNTY INSPECTORATE SERVICE BILL, 2024

NOTICE is given that Hon. Samson Zia Kahindi the chairperson Committee on Devolution, Public Service and Disaster Management intends to move the following amendments to the Kilifi County Inspectorate Service Bill, 2024 at the Committee of the Whole House stage.

1. **THAT**, Clause 10 of the Bill be amended by;
 - a) Deleting the phrase “holds any relevant degree from a university recognized in Kenya, and replacing it therefor with the words” possess a Master’s Degree in Security Management, Criminology or any other relevant related Social Science Master’s Degree from a recognized university in Kenya.
 - b) Adding a new Clause (c) with the words” Possess a Bachelor’s Degree in Security Management, Criminology or any other relevant Bachelor’s Degree from a recognized university in Kenya ”.
 - c) Renumbering the sub-clauses d, e and f accordingly.
2. **THAT**, clause 13 of the Bill be amended by;
 - a) Deleting the word “shall” appearing immediately before the word “Inspectorate” and replacing it therefor with the word “may”.
3. **THAT**, clause 26(h) be amended by;
 - a). Deleting the words Judicial Service Commission replacing it with the Judiciary.
4. **THAT**, phrase commandant appearing in interpretation clause 2 be amended by;
 - a) Deleting the words “also and Director” and replacing with the word “a person”.
