REF: COMMITTEE STAGE AMENDMENTS TO THE KILIFI COUNTY CITIZEN PARTICIPATION AND CIVIC EDUCATION BILL (KILIFI COUNTY BILL NO. 4), 2019

NOTICE is given that Hon. Scholastica A. Oduol, Chairperson to the Sectoral Committee in charge of Justice and Legal Affairs intends to move the following amendments to the Kilifi County Citizen Participation and Civic Education Bill, 2019 at the Committee of the Whole House Stage –

Clause 3

That, **Clause 3** be amended by inserting the following articles of the Constitution

Articles 35, 61, 69,118,119,196 and 184) of the Constitution

Clause 6(3)

That, **Clause 6(3)** be amended by inserting the following:

(g). A cluster representing the registered people living with disabilities

Clause 7(1) (c)

That, **Clause 7(1) (c)** be amended by deleting the following word "**degree**" and replace it thereof with the word "**diploma**

Clause 20(4)

That, **Clause 20(4)** be amended by inserting the following paragraph immediately after paragraph (d)

(e). Matters of planning and provision for civic education at all levels within the county and further rename sub clause **3** to sub clause **5**

Clauses 23A, 24,25,26,27

That, Clauses **23A, 24, 25, 26, 27, be** renumbered to Clauses **24, 25, 26, 27, 28** respectively

That **Part IV** be renamed **Part V**

Clauses 28,29,30,31,32,33,34 and 35

That, Clauses **28,29,30,31,32,33,34 and 35** Be renumbered to Clauses **34,35,36,37,38,39,40 and 41** respectively.

That **Part V** be renamed **Part VI**

Clauses 36, 37,38,39,40, and 41

That Clauses **36,37,38,39,40, and 41** Be renumbered to Clauses **42,43,44,45,46 and 47** respectively

INTRODUCTION OF NEW CLAUSES

PART IV— COUNTY CIVIC EDUCATION

NEW CLAUSE 29; County Civic Education Objectives

1. The county directorate of Citizens participation and Civic Education shall perform such activities to provide civic education for the objectives as follows;-
 - (a) To enhance knowledge and understanding on the constitution of Kenya 2010;
 - (b) To promote constitutionalism and up holding to the rule of law;
 - (c) To increase efficiency and effectiveness in implementation of Devolution;
 - (d) To support the expansion of citizen participation in public affairs and political processes particularly for the marginalized groups and communities;

- (e) To enhance effectiveness and efficiency in advocacy and lobbying for the implementation of community projects to quality basic service delivery by the duty bearers
 - (f) To promote fulfillment of access to human rights and responsibilities according to county government Act section 137
2. The county directorate shall appoint an officer in charge with civic education within the directorate

NEW CLAUSE 30: Civic Education Providers

1. The county directorate of Citizens participation and Civic Education shall provide guidance to the ward forum through the presiding of the ward administrators to facilitate the recruitment of the civic educators in the respective county wards
2. The civic educators will then be put under an intensive training in accordance to the National Civic Education Curriculum
3. The civic educators shall perform such tasks of organizing and providing quality civic education as volunteers who be facilitated with transport, airtime and stipends by the county government.

NEW CLAUSE 31: Qualifications of Civic Educators

The civic educators recruitment will be guided among other factors the following;-

- (a) Be a Kenyan citizen
- (b) Be 18 years and above
- (c) Be of sound mind
- (d) Good communication skills
- (e) Experience in community mobilization, organizational and facilitation skills
- (f) Should meet the requirement of the chapter six of the constitution of Kenya
- (g) Possess basic knowledge on the constitution of Kenya.
- (h) Should not be an official of any political party
- (i) None state actors
- (j) Certified civic education providers who are none state actors may conduct civic education in the county as per County civic education guidelines
- (k) None state actors shall coordinate with the directorate at all times as they carry out civic education

NEW CLAUSE 32: Civic Education Provision Avenues

The civic educators shall use the following avenues among other in providing civic education;-

- (a) Organized groups such as youth, men, women and self help groups, sport clubs and groups of people living with disabilities among others;
- (b) Community baraza;
- (c) Churches and mosques;
- (d) Public forums and;
- (e) Traditional gatherings

NEW CLAUSE 33: Reporting on Civic Education

The directorate shall publish a quarterly report on

- (a) Number of certified civic education providers available
- (b) Number of civic education secessions conducted by the civic educators
- (c) Number of citizens reached with civic education
- (d) Assessment of the impact of civic education conducted by the civic educators

Clause 1

That, **Clause 1** be amended by inserting the operational clause immediately after "**2019**"

"and shall come into force on the date of publication in the Kenyan Gazette ".

Clause 2

That **Clause 2** be amended by inserting the following definitions

"Citizen Participation" means the process and methods designed to consult, involve and inform the public or stakeholders in order to allow those who would potentially be affected by a decision, any policy, legislation, program, and project to have input in the process

"Civic education" means the process of giving information to the citizens on constitution and constitutionalism, human rights and responsibilities and how these rights can be accessed and exercised according to county government Act section 137.

"Stakeholders" means a person or group of persons who have an interest on public issues or who are likely to be directly or indirectly affected by a public issue, decision or policy whether negatively or positively
