Whether the County Executive Committee Member (CECM), Finance and Economic Planning and County Secretary are aware that the Secretariat started their meetings on the 26<sup>th</sup> of July 2022.

The offices are aware.

Whether the CECM, Finance and Economic Planning and the County Secretary are aware that the Secretariat was entitled to payment of allowances as provided for in the Salaries and Remuneration Commission (SRC) Circular No. SRC/ADM/CIR/1/13/ (122) of 16<sup>th</sup> April 2024.

The offices are aware.

Whether the CECM, Finance and Economic Planning and the County Secretary are aware that since the establishment of the secretariat and subsequent meetings to support the main committee, no payment of allowances has been made to the secretariat.

No, we are not aware of it because the details of the requests including the beneficiaries, details of the meetings, minutes, attendance schedules and the total claim have not been submitted to the current office bearers.
