**COUNTY PERFORMANCE MANAGEMENT PLAN**

**Hon. Kadenge:** Thank you Mr. Speaker. I wish to move a Notice of Motion regarding the performance management in the County Government of Kilifi that is through the County Secretary and Head of Public Service.

**Aware that,** section 47 (1) of the County Government Act, 2012 provides that the County Executive Committee shall design a Performance Management Plan to evaluate performance of the County Public Service and the implementation of County policies.

**Further aware that** section 47 (3) of the County Government Act 2012 provides that the Governor shall submit the annual performance of County Executive Committee and the public service to the County Assembly for consideration.

**Noting with concern that**, the County Assembly has not received the annual performance reports of the County Executive Committee and Public Service since inception.

**Further concerned that**, the absence of a performance management plan has caused non performance and underperformance within the County Executive Committee and public service. This Honourable House urges the County Secretary to come up with a County Performance Management Plan as provided for in Section 47 of the County Government Act, 2012 and ensure that annual performance reports for the County Executive Committee and the public service are submitted to the County Assembly for consideration. Thank you.
