OUTBREAK OF AN UNKNOWN LIVESTOCK DISEASE IN MWANAMWINGA WARD

This Statement is directed to the County Executive Committee Member (CECM) in charge of the Department of Agriculture, Livestock and Fisheries through the Chairperson; Agriculture, Livestock and Fisheries Committee:-

Whether the CECM is aware that there is an unknown disease outbreak in Mwanamwinga that has so far killed over 200 livestock.

Whether the CECM is aware that there has been low livestock vaccination for quite some time now despite having a Department and budgetary allocation for procurement of animal vaccines for every financial year.

If yes, why has there been no vaccination for the livestock within the county for a long period of time? As a matter of urgency, what plans and measures is the CECM taking to have the disease diagnosed and treated?
