It is my proposal that we do away with all the readings including the Second Reading of this Bill so that the same can transpire to the Third Reading and an assent by the Governor. After the assent, the Departments can now take up in completion of all the programmes enshrined in this Supplementary two Budget. Without much to say, may I call upon hon. Pascal Jacob Thuva, the Member for Mwanamwinga, to Second. Thank you.

**Hon. Pascal:** Thank you Mr. Speaker for this opportunity.
